## **Parent Representation on District Standing Committees**

The attached letter from Ms. Jen Mezei, Burnaby DPAC Chairperson, includes a request for expanded parent representation on the district standing committees listed below. This request is in addition to the existing parent representation on the district's Education Committee:

- Buildings and Grounds
- Policy
- Youth and Community Services

Parent participation on district standing committees exists in some districts within the province and, as mentioned above, the Education Committee of the Board has successfully functioned with parent representation for a number of years. Parent representation on district standing committees may impact the operation of the committee, particularly in areas where "in camera" discussion is required; however, it is generally believed that these issues can be accommodated for the three additional committees identified.

The Board's existing procedural bylaw does not preclude the addition of parent representation on standing committees. The procedural bylaw does contemplate the appointment of non-trustees to standing committees in Part 5, paragraph 1(i), as follows:

The Board may appoint non-trustees to be regular participants in standing committees. Board-appointed participants may fully participate in the committee meetings but only appointed Trustee members of the committee may vote.

The attached correspondence also acknowledges that, in accordance with the district's procedural bylaw, parents' role on the committees would be as fully participating non-voting members.

If the Board wanted to implement a change to permit parent representation on the standing committees as requested, it would be appropriate to approve a motion as follows:

That the Board of Education approve the appointment of a DPAC representative to the following standing committees: Buildings and Grounds, Policy, Youth and Community Services in accordance with Part 5, paragraph 1(i) of the Board's Procedural Bylaw for the remainder of the 2011/2012 school year.
