Board Chair Report

Chair Baljinder Narang noted that Friday, April 25 is Public Education Day in BC. Burnaby's public school system has supported the learning needs of generations of families for 107 years. The district has been fortunate to have had leaders with vision and passion, including Vice-Chair Ron Burton who has been a Burnaby trustee for 25 years. Ms Narang highlighted some of the changes that had taken place in the district during that time and thanked Mr. Burton for his commitment and dedication to Burnaby's public schools.

Superintendent's Report

Burnaby's Got Talent

Superintendent of Schools Kevin Kaardal outlined the history of the competition that had been organized by the District Student Advisory Committee for the last ten years.

Director of Instruction Ron Hall introduced DSAC Co-Presidents Allie Graham and Kieren Gadhia who informed Trustees that this year's competition had sponsored the Burnaby Task Force on Homelessness and had raised 5,508.92 - the highest amount in its ten-year history. This year's winner, Byrne Creek International Education Student Huahaohao Zhang, performed her winning aria *o mio babbino caro*.

French Immersion Public Speaking Contest

Mr. Kaardal outlined the background to the district's French Public Speaking Contest, *Concours d'art oratoire*, a collaboration between Canadian Parents for French and the school district. Students in grades 6 to 12 in Francophone, French as a Second Language and both early and late French Immersion programs participate in the *Concours*.

Director of Instruction Ron Hall introduced Cascade Heights teacher Heidi Wilson and participants Maddy Gomes (Cascade Heights, grade 6 early French Immersion) and Hamish Clinton (Alpha, grade 9, French Immersion). Maddy and Hamish, winners in their categories, repeated their speeches for trustees.
