1. Capital Project Bylaw No. 126757

On March 14, 2014 the Ministry of Education announced the 2014/2015 Annual Facility Grant funding for the ongoing maintenance of school facilities. Total funding approved for the Burnaby School District was \$4,659,318, of which \$3,649,144 was to be funded through a capital grant. To access the capital grant funding, the Board is required to adopt Capital Project Bylaw No. 126757 in the amount of \$3,649,144. A copy of the pro-forma capital project bylaw is attached for reference.

Recommendation

It is recommended that Capital Project Bylaw No. 126757 receive three readings at this Board meeting and final adoption in accordance with the Board's Procedural Bylaw as follows:

CAPITAL PROJECT BYLAW NO. 126757

A BYLAW by the Board of Education of School District No. 41 (Burnaby) (hereinafter called the "Board") to adopt a Capital Project.

WHEREAS in accordance with provisions of the *School Act* the Minister of Education (hereinafter called the "Minister") has approved Capital Project No. 126757.

NOW THEREFORE the Board agrees to the following:

- (a) upon approval to proceed, commence the Project and proceed diligently and use its best efforts to complete the Project substantially as directed by the Minister;
- (b) observe and comply with any rule, policy or regulation of the Minister as may be applicable to the Board or the Project; and,
- (c) maintain proper books of account, and other information and documents with respect to the affairs of the Project, as may be prescribed by the Minister.

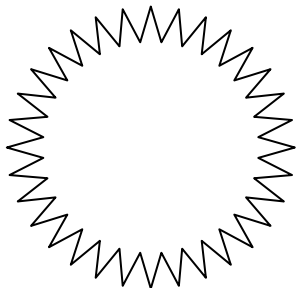
NOW THEREFORE the Board enacts as follows:

1. The Capital Project of the Board approved by the Minister and specifying a maximum expenditure of \$3,649,144 for Project No. 126757 is hereby adopted.
2. This Bylaw may be cited as School District No. 41 (Burnaby) Capital Project Bylaw No. 126757.
