1. Capital Project Bylaw No. 126632

On March 18, 2013 the Ministry of Education announced the 2013/2014 Annual Facility Grant funding for the ongoing maintenance of school facilities. Total funding approved for the Burnaby School District was \$4,378,006, of which \$3,263,604 was to be funded through a capital grant and the remainder \$1,114,402 through a special purpose grant.

On July 16, 2013 the Ministry announced that the split of funds between operating and capital has changed and that \$3,367,831 will be funded through a capital grant and the remaining \$1,010,175 through a special purpose grant. There is no change to the total amount of the Annual Facility Grant funding. To access the revised capital grant funding, the Board is required to adopt a Capital Project Bylaw No. 126632 in the amount of \$3,367,831. A copy of the pro-forma capital project bylaw is attached for reference.

Recommendation

It is recommended that Capital Project Bylaw No. 126632 receive three readings at this Board meeting and final adoption in accordance with the Board's Procedural Bylaw as follows:

NOW THEREFORE the Board agrees to the following:


- upon approval to proceed, commence the Project and proceed diligently and use its best (a) efforts to complete the Project substantially as directed by the Minister;
