# Superintendent's Report

## School Opening Report

Acting Superintendent Heather Hart presented the School Opening Report, highlighting many of the startup activities happening in schools. She welcomed new and returning families and indicated enrolment will be close to projections. A detailed enrolment report will be brought to the Board at a future meeting.

## The Learning Never Stops

District Principal Donna Scott provided an overview of the District's Summer Session. Ms. Scott provided some details of the learning opportunities offered this summer. The district hosted 8,500 students and classes were held at 24 Burnaby school locations. Some of the courses provided students extra help to develop skills for lifelong learning or extra support for learning challenges.

In addition to the summer session academic programs, childcare and preschool programs were offered at 17 elementary schools. As well, three secondary schools, Burnaby South, Byrne Creek and Burnaby Mountain, were used as sporting venues for the British Columbia Seniors Games, hosted by the City of Burnaby from August 21 to 25.

Summer site coordinator, Nancy Sinclair introduced two students who shared their experience at summer session. Andrew Ma, Grade 5, enjoyed a positive experience and will go back next year. Devon Roger attended his second year of summer session to improve his work and get ready for Grade 4.

Meeting the Challenge of Grade 7 to 8 Transitions through Collaboration and Mentorship

Burnaby North Principal Kevin Brandt, highlighted the transition program that helps students transitioning from Grade 7 to Grade 8 feel connected and safe. Students attended their secondary school in August with a mentor, and information sessions and tours were held to help them become familiar with the school culture and the facilities.

Mentor Isabella McKenna, a Grade 12 Student, provided a survival guide to help students get ready for the school year. Nico Ghisi, Grade 10, shared his experience and indicated he appreciated the help mentors provided him when he entered Grade 8. Mrs. Osellame and her Grade 8 son Marco Osellame shared their positive experience with Burnaby North's transition process into secondary school.
