#### **Superintendent's Report**

'Rhythms for Life' Drum-a-Thon

Eva Young, Vice-Principal of Ecole Marlborough Elementary School, and Geraldine Lazaruk, music teacher, outlined the drum-a-thon fundraiser being held in support of Syrian refugees at Marlborough the following evening. Students Manya Sharma and David He shared some of their thoughts on what the event meant to the school community. Accompanied by Martin Nemcovsky, music teacher, the students performed a group composition entitled "Dreamland".

#### Settlement Support in Burnaby Schools

Heather Hart, Assistant Superintendent, described the Settlement Workers in Schools ("SWIS") program that has been in the district since 2007. The current program staff of 12, together with coordinator Natalya Khan, have refugee backgrounds and speak 15 languages between them. The district is prepared for and will welcome Syrian refugees; 47 per cent of Burnaby's student population speak a language other than English and many will be able to welcome refugee students in their native language.

Ms Khan described how the SWIS program welcomes and processes refugee families and the programs that are available to them. Hafal Ahmad and Souad Hage-Hassam, settlement workers, helped the Jasim and Saela families and students Barfin, Adam Ahmah and Ojalan Zakaria share their experiences in coming to a new land.

Capital Project Bylaws No. 127006 and 127007

Mr. Frank explained that in order to access this capital project funding the Board is required to adopt Capital Project Bylaw No. 127006 in the amount of \$205,800 for Aubrey Elementary School and Capital Project Bylaw No. 127007 in the amount of \$315,000 for Stride Avenue Community School.
