# 1. Amended Annual Budget Bylaw for the Fiscal Year 2018/2019

#### Background

In December of each year, the Ministry of Education recalculates the grants provided to school districts for their annual budget based upon the actual September 30 enrolments and other funding formula data. As Trustees are aware, the preliminary ministry funding and the district's preliminary annual budget prepared in April 2018 were predicated on enrolment and other funding estimates which now need to be adjusted to reflect actual funding and expenditure experience. The attached pro-forma Amended Annual Budget Bylaw in the amount of \$295,206,174 reflects the district's current updated annual budget for the 2018/2019 fiscal year.

Russell Horswill, Secretary-Treasurer, will make a presentation on the 2018/2019 amended annual budget for board consideration and approval.
