4041 Canada Way Road Dedication and Consolidation Bylaw, 2019

As part of the board office replacement process the Board must acquire a building permit from the City of Burnaby to build the new Admin Office on the site of the former Schou Continuing Education Centre at 4041 Canada Way. As a condition of approving the building permit the City of Burnaby requires the Board to dedicate as road the areas marked on Schedule A of the attached bylaw and to consolidate the remainder of the twelve parcels of land that currently comprise the Schou property. The road dedication and consolidation will not interfere with the Board's use of the property for educational purposes, including the construction and operation of the new board office.

Recommendation

It is recommended that 4041 Canada Way Road Dedication and Consolidation Bylaw, 2019 receive three readings at this Board meeting and final adoption in accordance with the Board's Procedural Bylaw as follows:

4041 CANADA WAY ROAD DEDICATION AND CONSOLIDATION BYLAW, 2019

WHEREAS section 65 (5) of the *School Act* provides that a board of education may exercise a power with respect to the acquisition or disposal of property owned or administered by the board only by bylaw;

AND WHEREAS pursuant to Section 96 (1) of the *School Act*, "land" includes any interest in land, including any right, title or estate in it of any tenure;

AND WHEREAS:

- (i) The Board of Education of School District No. 41 (Burnaby) (the "**Board**") owns land on which it has operated the Schou Continuing Education Centre (the "**Property**");
- (ii) The Board requires a building permit to build a new administration building on the Property;
- (iii) As a condition of approving a building permit for the Property, the City of Burnaby (the "City") requires the Board to dedicate as road (the "Road Dedication") the areas marked "DEDICATED AS ROAD" on Subdivision Plan EPP68679 (the "Subdivision Plan"), a reduced copy of which is attached to this Bylaw as Schedule A, and to consolidate into one parcel (the "Consolidation") the remainder of the twelve parcels of land that currently comprise the Property;
- (iv) The Property is facility number 41045;
- (v) The address of the Property is 4041 Canada Way, Burnaby, British Columbia, V5G 1G6, and the legal description of the Property is:

NOW THEREFORE be it resolved as a Bylaw of the Board that the Road Dedication and the Consolidation be and are hereby approved.


