Construction updates are summarized for the Board Office, Burnaby North Secondary, Parkcrest and Seaforth Elementary schools and for the phase 2 childcare projects, and Land Consolidation at Kitchener and Glenwood Elementary Schools are underway.

Introduction:

Background:

The Burnaby Board of Education's 2019-2024 Strategic Plan contains the following objectives under the key priority "A Modern, Safe and Sustainable Learning Environment", Goal 2 – Develop a Long-Range Facility Plan consistent with Ministry Guidelines:

- i) Collaborate with the City of Burnaby as they update their Official Community Plan (OCP) to inform future enrolment projections.
- ii) Develop and implement a multi-year strategy to seismically mitigate all schools with a "High" (H1, H2, or H3) government rating.

A significant number of capital projects are active and are at various stages. Below is a summary of all projects and their associated state.
