<u>Background:</u>

The Accessible British Columbia Act came into effect September 1, 2022. It applies to prescribed organizations including school districts and independent schools as of September 1, 2023.

In 2019, the Provincial Government engaged in widespread consultation through an Accessibility Legislation Consultation Advisory Committee. The Committee concluded that British Columbians strongly supported the development of accessibility legislation and that more needed to be done to move towards an environment that was inclusive of all people, especially in education and employment.

Information:

The Act aims to increase all persons' ability to meaningful participation in their communities by attempting to remove barriers through the development of accessibility standards. To do so, the Act requires certain organizations, including school districts and independent schools, to make their organizations more accessible.

Key objectives are:

Increase meaningful participation in communities (including in schools);

Develop standards for improved services delivery in areas such as education including critical infrastructure like entranceways, playgrounds, sidewalks, accessible transportation, employment opportunities; and

Harmonization with other jurisdictions, including federal requirements.

Accessible British Columbia Act

The Accessible British Columbia Act aims to support the **identification**, **prevention**, and **removal** of **barriers** that people with disabilities face in their day-to-day lives.

There are more than 926,000 British Columbians with some form of disability – representing almost 25% of the population.



Accessible BC Act - Goals

- Increase meaningful participation in communities
- **Develop** standards
- Enhance service delivery
- Harmony with other jurisdictions

Accessible BC Act - Key Themes

Generally

- Breaking down barriers
- Advancing human rights
- Promoting fairness
 and equity

Specifically

- Increased visibility of those with disabilities
- Public campaigns to include those with disabilities in public systems, such as education and transportation
- Development of targeted education and training programs
- Increased integration in communities
- Focus on accessibility, empathy, and sensitivity training



Definitions in the Act

Disability

 An inability to participate fully and equally in society as a result of the interaction of an impairment and a barrier

Barrier


- Essentially, anything that stops those with disabilities from being included
- Specifically, anything that hinders the full and equal participation of a person with an impairment

Impairment

• A physical, sensory, mental, intellectual, or cognitive impairment which is permanent, temporary, or episodic

Requirements for Public Sector Organizations

The Act requires that prescribed public sector organizations establish:





Accessibility Committee

Public sector organizations are required to establish an "accessibility committee"

The accessibility committee is required to:

- **Assist** in identifying barriers
- Advise in removal/prevention



The Accessibility Plan – Key Components

The accessibility committee must assist in developing a public accessibility plan.

The role of an accessibility committee is to:

Develop a plan to identify, remove, and prevent barriers to individuals in or interacting with the organization.



Establish a process for receiving comments from the public on the accessibility plan and on barriers to individuals in or interacting with the organization.

Assist the organization in reviewing and updating its accessibility plan at least once every three years.

Priority 1 - Accessibility Awareness and Training

Objective: To increase awareness of our collective and individual responsibilities to create and maintain inclusive, barrier-free environments.

Barrier: Attitudinal Barrier Actions: To begin October 2023 **Priority 2 - Accessible Information and Communication**

Objective: To enhance the accessibility of information and communication for all individuals, including those with disabilities.

Barrier: Information and Communication Barriers

Actions: To begin January 2024

Priority 3 - Physical Barrier Scan

Objective: To identify common physical barriers by engaging all stakeholders in a barrier assessment of our district.

Barrier: All

Actions: To begin April 2024, from 2023
